Mr. Waybright made a motion the Disability Committee approve the recommendations from staff for the three disability TRS (TDC Transfers) approved effective nunc pro tunc (retroactive) to 8-30-2017, the date of the last Board meeting. The motion was seconded by Mr. Lynch. The motion carried unanimously.

Captain Corsaro made a motion the Disability Committee approve the disability recommendations from staff. The motion was seconded by Mr. Haney. The motion carried unanimously.


**Tab 3: Other Business**
